How much income does a family sponsor with a WORK PERMIT need to reunite their family?



#### Sponsor

Family member who lives in Finland and has a work based residence permit



#### Family member

A family member living elsewhere who is applying for a residence permit in Finland. (Spouse or minor child)

## Examples of different families:

#### 2 adults



Family Sponsor's minimum income

1090€+550€  
= **1640 €/kk**  
(after taxes)

#### 2 adults + 1 child



Family Sponsor's minimum income

1090€+550€+550€  
= **2190€/kk**  
(after taxes)

#### 2 adults + 2 children



Family Sponsor's minimum income

1090€+550€+550€+430€  
= **2620€/kk**  
(after taxes)

### Sponsor

## Examples of different families:

### 2 adults



Family Sponsor's minimum income

1030€+520€  
= **1550 €/kk**  
(after taxes)

### 2 adults + 1 child



Family Sponsor's minimum income

1030€+520€+520€  
= **2070€/kk**  
(after taxes)

### 2 adults + 2 children



Family Sponsor's minimum income

1030€+520€+520€+410€  
= **2480€/kk**  
(after taxes)

# Work Based residence permit

## Accepted income

What is considered income when applying for extension for permit?

### Please note:

- When the spouse is already in Finland, the income of both family members is added together.
- The sooner your spouse is studying or working, the better it is in terms of permits.



### Accepted income

- Salary, income from work (after taxes)
- Savings in your own bank account
- Child maintenance allowance
- Child care allowance
- Child benefit
- Student allowance
- Housing allowance

### Be careful!

- **Social assistance**
  - only when you have a temporary need or an emergency
- **Unemployment benefits**
  - if employment does not correct the situation during the application (Don't wait long while laid off, look for a new job IMMEDIATELY!)
- **Unsettled debts, loans and recoveries**
  - All unsettled financial matters can make it difficult to obtain a permit
  - Please try to avoid buying on credit
  - Please make sure child support payments are taken care of if you are divorced and have minor children.
